1. APOLOGIES FOR ABSENCE

Apologies had been received from Cllr Bean but the latter's views on the agenda had been discussed in advance with the Clerk and she represented them at the meeting.

2. DECLARATIONS OF INTEREST

There were no declarations of interest.

3. MINUTES OF THE MEETING HELD ON 22 JUNE

The Minutes of the Parish Council meeting held on 22 June were unanimously approved by all present and were signed by the Chairman.

4. MATTERS ARISING

4a) There were no matters arising from the Minutes.

5. QUESTIONS FROM MEMBERS OF THE PUBLIC

There were no questions from members of the public.

6. FINANCE

- 6a) It was noted that Fred Jefferies had received payment for work in July/early August plus petrol and two cheques had been signed for £58.99 and £54.00 respectively.
- 6b) It was unanimously agreed to pay Fred Jefferies for outstanding work in August and a cheque for £81.00 was signed. SF had bought petrol at a cost of £5.34 and was reimbursed by cheque and Mr Hamlin had repaired the strimmer at a cost of £40.00 and was reimbursed by cheque.
- 6c) It was noted that a payment of £1750.00 had been received on 8 September for the second half of the precept.
- 6d) It was unanimously agreed that an annual grant of £110.00 would be paid to the village hall towards the maintenance of the defibrillator and a cheque was signed.
- 6e) Following further consideration of the Internal Auditor's Report Letter, Councillors conducted a thorough review of the effectiveness of internal audit. Having given the matter due and careful consideration, Councillors reached the conclusion that everything was in good order and all systems were robust.
- 6f) It was noted that Tim Light had accepted a post which meant he could no longer act as Internal Auditor to Bourton Parish Council. However, he had recommended a colleague, Eleanor Greene of Do the Numbers Ltd, who was willing to conduct the internal audit for the same fee of £175.00. It was unanimously agreed to appoint her and the letter of engagement would be signed at the next meeting.
