

PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER
HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981

**The Oxfordshire County Council,
Bourton Footpath No 4 (part),
Public Path Diversion and Definitive Map and Statement Modification
Order 2022.**

This Order is made by The Oxfordshire County Council ('the authority') under section 119 of the Highways Act 1980 because it appears to the authority that in the interests of the owner of the land crossed by the public right of way described in Article 1 of this Order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Oxfordshire County Council Definitive Map and Statement of Public Rights of Way for Oxfordshire require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the way into a fit condition for use by the public.

Vale of White Horse District Council has been consulted as required by Section 120(2) of the Highways Act 1980.

BY THIS ORDER:

1. The public right of way over the land situated at Pinewood School in the parish of Bourton and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be extinguished on the date upon which the Oxfordshire County Council as highway authority certifies that the route described in paragraph 2 (below) has been brought into a fit condition for the use by the public and thereupon the Oxfordshire County Council Definitive Map of Public Rights of Way for Oxfordshire shall be modified by deleting from it that public right of way, and the Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order.
2. There shall be from the date of confirmation a public footpath over the land situated at Pinewood School in the parish of Bourton (as described in Part 2 of the Schedule) and shown by a bold broken line on the map attached to this Order, and thereupon the Oxfordshire County Council Definitive Map of Public Rights of Way for Oxfordshire shall be modified by adding that right of way to it, and the Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order.

3. Notwithstanding this Order, statutory undertakers with apparatus over/under the land described in Article 1 above shall continue to have the same rights in respect of such apparatus as they had immediately before the date of this Order.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING WAY

The entire width of Bourton FP 4 running from its junction with Bourton FP 5 at OS Grid Ref SU 2305 8709 (Point C on the Order plan) south-westwards via SU 2286 8698 (Point B) for approximately 298m to SU 2281 8691 (Point A).

PART 2

DESCRIPTION OF SITE OF NEW WAY

A new footpath running from Bourton FP 6 at OS Grid Ref SU 2295 8711 (Point L on the Order plan) south-westwards via SU 2289 8708 (Point K), SU 2287 8705 (Point J), SU 2284 8703 (Point I), SU 2283 8702 (Point H) for approximately 169m to SU 2282 8700 (Point G), then south-south-eastwards for approximately 20m to SU 2283 8699 (Point F), then west-south-westwards for approximately 21m to SU 2281 8697 (Point E) and then southwards for approximately 61m via SU 2280 8693 (Point D) to SU 2281 8691 (Point A) where it re-joins the existing Bourton FP 4.

Widths:

4m between OS Grid Ref SU 2295 8711 (Point L on the Order plan) and SU 2284 8703 (Point I).

2m between SU 2284 8703 (Point I) and SU 2283 8702 (Point H).

2.5m between SU 2283 8702 (Point H) and SU 2281 8691 (Point A).

PART 3

The right of the landowner to install a pedestrian gate at OS Grid Reference SU 2283 8702 (Point H).

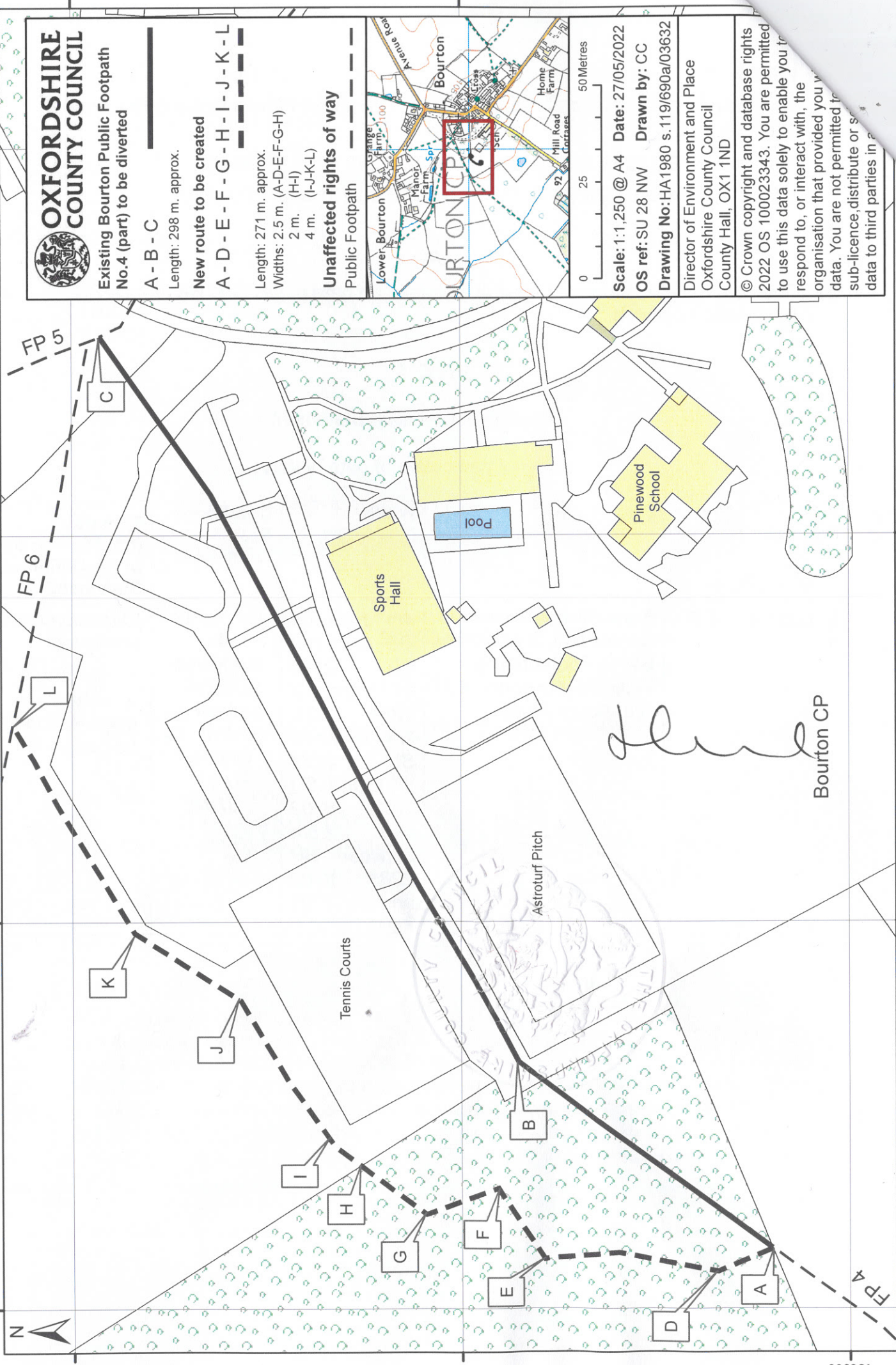

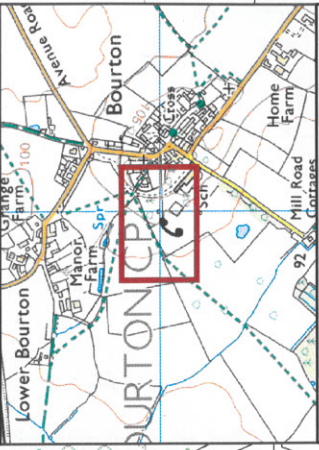
